The At-Risk Program staff provides at-risk students with supplemental advisement, support, and follow-up, and acts as "broker" of campus-based and community services. Delta College's At-Risk Program is staffed by an Advisor (M. Carter) and a Student Development Specialist (S. Chandran). In 2007-08, the following services were provided: 1) 140 students received counseling/advising services; 2) 30 students used Plato; 3) 218 students participated in the Productivity Environmental Preference Survey; 4) 1,176 students received tutoring; 5) 1,000 students received Structured Learning Assistance services; 6) 85 students participated in Study Groups in Math and Nursing; 7) 18 student athletes participated in weekly study sessions; and 8) 10 students participated in a new online tutoring program "Cyber Tutor". A total of 2,677 unduplicated at-risk students received supplemental support services ...

At-Risk students at Gogebic are first identified through the admissions process, direct staff contacts, self-identification at orientation, and through faculty referral. Supplemental intensive advising services are then provided, along with development of academic and career goals, and arrangements for specialized service opportunities including tutoring and accommodations for special learning needs. As the year progresses, faculty continue to make referrals and students are asked to meet with staff for identification/review of barriers to success, academic and/or counseling support, reassessment of course load, reestablishment of short and long term academic and career goals. At-Risk funding also provides individual and group peer tutoring in most subject areas on campus.

<p>Success rate in developmental math course increased due to a piloted program implementing in class math coaches; Foundation Studies students who participated in the one credit First Year Seminar course persisted from Fall to Winter at a rate of 81%; JCC has increased its focus on instructional strategies. This fall over 955 developmental students enrolled in FYS classes. The Center for Students Success is serving an average of 400+ students a week providing, peer and faculty tutoring in the areas of math, reading, writing, science, the humanities and computers. Students entering KVCC have been assessed in reading, writing, and math skills (COMPASS) and have participated in orientation sessions. Assessment results have been reviewed with academic counselors and students have been advised and registered for courses including, as necessary, developmental/ transitional classes.

If students require specific services to support their instructional experiences, a broad range of services are available, including special services (interpreters, adaptive equipment, etc), tutoring (CRLA certified), student advocates, career advisors, financial aid, counseling, social organizations, athletic and cultural activities. For ESL/LEP students an "ESL Chat" session is held weekly to augment tutoring activities and to encourage students to converse informally. Rosetta Stone and Guide to American English Pronunciation software was also used to improve English p ...

Summary of Accomplishments (Limit of 10 lines)</p> <p>The Developmental Studies Department has conducted several studies to assess the success of its students in both developmental and non-developmental courses. Research shows that developmental writing students are succeeding in the next composition course at rates comparable to non-developmental students. The same is true for elementary algebra students who take intermediate algebra. On the other hand, data has confirmed instructor observation about the need for a pre-algebra course. In fall '09, students will place into College Arithmetic, Pre-Algebra, or Elementary Algebra at the time of initial assessment testing. The elementary algebra curriculum piloted last year has now been fully implemented. The college added a full-time composition instructor, thus increasing the number of developmental writing courses taught by full-time instructors.</p>

There were 232 student needing disability related accommodations, tutoring and/or counseling that met with the Academic Achievement Center counselor. The counselor also conducted presentations to developmental reading and English courses regarding available tutoring and disability services. In addition, students enrolled in these courses worked with the Academic Center's instructional support specialist to utilize the computerized educational software programs to supplement their instruction. Not included as documented "at-risk" are the many students using drop-in tutoring, group tutoring, supplemental instruction and computer tutorials. At-risk funds provided financial support for one part-time counselor, one part-time instructional specialist, and approximately 25 tutors and disability providers.
