3. Summary of Accomplishments (Limit of 10 lines)
Instructors provided a wide variety of supplemental materials. These materials were made available to students outside of the classroom to augment and facilitate tutoring and individual and group study time. Free tutoring was offered for many subjects. Tutoring was provided to at-risk students during the fall semester to 197 for 914 hours, during the spring semester 172 received 871.75 hours, and during the summer semester 10 received 57.25 hours. Appropriate placement was provided by the Testing Center. Placement guidelines have been established and are reviewed by English and math/science department chair persons. Alpena Community College evaluates services to students annually. Recommendations for improvements in delivery of services are generated and implemented with students' needs in mind.

<p>3. Summary of Accomplishments (Limit of 10 lines)</p> <p>The At-Risk grant expanded to serve more students during the 2010-11 year. In addition to the tutoring services provided to students who visit the Math Empowerment Center, the grant also provided tutoring services to students who visited the Writing Center.</p> <p>The Writing Center has existed at Mott Community College for many years, but has recently seen an increase in the number of students seeking writing assistance in areas outside of the English and Literature departments. Funds were provided to provide the expertise of four full-time faculty to assist both tutors and students.</p> <p>In the summer of 2011, a tracking system was purchased with At-Risk grant funds to enable the tracking of student visits to each Center. Two computers and swipe card keyboards, were placed in each Center as a tool for gathering information on the students who are visiting. Tutor Trac is in its first phase.</p>

Summary of Accomplishments (Limit of 10 lines)</p> <p>The At-Risk Program staff provides at-risk students with supplemental advisement, support, and follow-up, and acts as "broker" of campus-based and community services. Delta College's At-Risk Program is staffed by an Advisor (M. Carter) and a Student Development Specialist (S. Chandran). In 2010-11, the following services were provided: 1) 336 students received counseling/advising services; 2) 296 students used Plato; 3) 45 students participated in the Productivity Environmental Preference Survey; 4) 1,895 students received tutoring; 5) 1,731 students received Structured Learning Assistance services; 6) 141 students participated in Study Groups in Math and History; 7) 40 student athletes participated in weekly study sessions; and 8) 38 students participated in the online tutoring program "Cyber Tutor". A total of 3,261 unduplicated at-risk students received supplemental support services.</p>

Summary of Accomplishments (Limit of 10 lines)</p> <p>At-Risk students at Gogebic are first identified through the admissions process, direct staff contacts, self-identification at orientation, and through faculty referral. Supplemental intensive advising services are then provided, along with development of academic and career goals, and arrangements for specialized service opportunities including tutoring and accommodations for special learning needs. As the year progresses, faculty continue to make referrals and students are asked to meet with staff for identification/review of barriers to success, academic and/or counseling support, reassessment of course load, reestablishment of short and long term academic and career goals. At-Risk funding also provides individual and group peer tutoring in most subject areas on campus.</p>

Services include ASSET/COMPASS placement test, interpretation for course placement in English and Math. Academic advising is provided for course placement to tested proficiency levels to promote students success, retention, and completion. Counselors work with Assisted Learning Services, ESL, and the Learning Lab to assure students receive tutorial assistance and developmental support services as needed. They also provide career guidance to support realistic career choices and offer workshops, seminars, as well as courses in career/life planning, parenting, college success, test anxiety, and human potential all to further support students education and career goals. Counselors provide personal counseling and referral services to assist students with personal concerns.</p>

Transitional courses are offered as regular classes and utilizing PLATO. Some transitional courses have in-class student advocates/tutors connecting students directly with resources. In addition to tutoring services, sessions are provided for basic skill development, time management, paper writing, note taking and study skills. Approximately 49% of registered disabled students fall under the category of "learning disabled" (LD/ADD). These students self-identify or are referred and receive additional services as needed.</p>

<p>3. Summary of Accomplishments (Limit of 10 lines)</p> <p>During 2009-2010, Lake Michigan College experienced an enrollment surge which significantly impacted services to At-Risk students. The total number of students served by At-Risk funding is up by nearly 20% over 2008-2009. This level of service continued through the 2010-2011 school year. The college continued to fund the Learning Assistance Coordinator and tutors with this grant during 2010-2011. Tutoring usage increased by 22% (approximately 147 additional tutoring session attendees). The college has also funded a part-time Academic Success Coordinator through this grant since 2006. Our data indicates that persistence and retention of new At-Risk students has increased consistently over this five year time span. We predict that this will continue to increase due to student success initiatives. Technology purchases made with grant funds during this grant year included, A Look at Production.</p>
